HOME PAGE

- The Website can be found at http://cilpublic.cil.ie/latonsonline
- Regular users should add the website address to their "Favourites" items
- To enter the website: Click on the "Login" text, as shown below



LOG-IN PAGE

- To Log-in, enter your Username and Password in the boxes provided.
- Ensure that both the Username and Password are in the correct case.
- To enter the site: Click on the "Login" button, as shown below.



WELCOME PAGE

- Welcome, you have successfully logged in to the Irish Lights AtoN Web Portal.
- Click one of the links shown below to continue.



AtoN PAGE

- From here you can view your AtoN list, AtoN details, apply for statutory sanction or enter quarterly failure report data online.
- A complete list of AtoNs allocated against your LLA is displayed here. This list can be filtered by using the drop down list as shown below.
- Details on individual AtoNs can be viewed by selecting the individual AtoN line and clicking on the "View Aton Details" button on the menu bar, or by "double clicking" on the individual AtoN line.



Submitting an Application

- Application for Statutory Sanction to establish an AtoN can be submitted online by clicking on the "Establish an Aton" button and completing the form.
- The fields indicated by an * below are essential. Irish Lights will allocate an AtoN Number when
 processing the application.
- Application for Statutory Sanction to alter or disestablish an AtoN can be submitted online by selecting
 the individual aid and clicking on the "Alter selected Aton" or "Disestablish selected Aton" button.
- The Application is submitted by clicking on the "Save" button.
- To submit an Application by post, click on the "Print Blank Form" to print a form.



APPLICATIONS PAGE

- All of your Statutory Sanction Applications records are shown here.
- Full details of individual applications can be viewed by selecting the individual application line and clicking on the "View the Application" button, or by "double clicking" on the individual line.



FAILURE REPORTS PAGE

- All your previously submitted Failure Reports are shown here.
- New Failure Report information can be entered by clicking the "New Report" button.
- Historical availability data can be individually displayed by AtoN, by using the "Search" function.



Entering Failure Report Data

- By clicking on the "New Report" button, the data entry screen is displayed as shown below
- An individual "New Report" is required for each casualty.
- The "Aton" and "Report Reason" can be selected from the drop down lists as shown overleaf.
- Dates are selected by clicking on the small arrow adjacent to the date box. Times are entered in the boxes below (24hr clock).
- The report is submitted by clicking on the "Save" button.




Entering Failure Report Data
